<b>Assessment Arrangements</b>	<p>Assessment will be conducted individually on the final day of your course. National mandated assessment instruments are used in the form of a practical assessment followed by a written assessment.</p> <p>You will be required to complete assessments in class. The written assessment is in closed-book conditions.</p> <p>You will be advised by your trainer and assessor about the assessment requirements during the course.</p>
<b>Course Credit</b>	<p>O'Brien Boiler Services can grant you credit towards your course for units of competency that you have already completed with another RTO or authorised issuing organisation. <b>Recognition of Prior Learning (RPL)</b>	<p>Recognition of Prior Learning (RPL) is a process where skills and knowledge that you have gained through work and life experience and other unrecognised training can be formally recognised.</p> <p>O'Brien Boiler Services has a process that has been structured to minimise the time and cost to applicants and provides a supportive approach to students wishing to take up this option. You will need apply for RPL at the time of enrolment.</p> <p>During the entry process and interview stage O'Brien Boiler Services will discuss with you the process and options for RPL. Suitability is often determined on how much experience you have in a certain area, your work history and previous training. If RPL is determined as a possibility for you, you will be provided with documents that will guide you in working through the unit to determine relevant skills and experience and identify whether you would be able to provide the required evidence. You will still need to complete the mandated assessment as this is requirement of the course.</p> <p>A trainer/assessor will be available to assist you throughout this process.</p> <p>*Please refer to your Student Handbook for more information on RPL.</p>
